N.C. DEPT. OF JUSTICE - ATTORNEY GENERAL'S OFFICE
APPELLATE SECTION

ELIGIBILITY: Rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: Pursuant to N.C.G.S. § 114-2 (1), the Attorney General represents the State in all criminal cases in the appellate courts of North Carolina. The Appellate Section of the Criminal Division of the North Carolina Department of Justice tracks and coordinates the handling of all criminal appellate matters and provides a group of attorneys who specialize in criminal law, criminal procedure, and criminal appellate matters who can handle the most difficult and complex criminal appeals and petitions.

The Appellate Section's primary responsibility is to represent the State in all criminal matters before the North Carolina Court of Appeals and the Supreme Court of North Carolina. This includes direct appeals of criminal convictions in any of the judicial districts of the State and state post-conviction petitions (non-capital) filed in the North Carolina appellate courts. The attorneys in the section also respond to petitions related to direct appeals filed in the Supreme Court of the United States. Because of their expertise, the attorneys also are able to serve as a resource for all of the attorneys in the Department of Justice who handle occasional criminal appeals as part of their duties through the criminal brief rotation.

INTERN DUTIES: Interns will assist attorneys in legal research and writing involving direct criminal appeals in the North Carolina appellate courts --- i.e., interns will research and draft parts of briefs filed in the appellate courts. They also may assist in updating appellate resource materials; and may help in preparing attorneys for oral arguments.

IN THE PAST: Past interns have drafted petition responses and appellate briefs, have assisted in updating issue banks and other appellate resource material, have helped prepare attorneys for oral argument, and have attended oral arguments at the appellate courts.

BENEFICIAL EXPERIENCES: Working in the Appellate Section allows interns to improve their legal research and writing skills and obtain experience in the preparation of documents for filing in criminal appeals. Interns have the opportunity to assist in advocating a position on behalf of the State of North Carolina that may impact the disposition of a case or affect the jurisprudence of the state with regard to criminal prosecutions.

N.C. DEPT. OF JUSTICE - ATTORNEY GENERAL'S OFFICE
COMPOSITE LITIGATION GROUP

THOSE ELIGIBLE TO APPLY: rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The Composite Litigation Group features attorneys who have been specifically designated to represent State agencies in complex or protracted litigation that arises out of the Administrative Division of the Department of Justice. The Group's clients include the Department of Health and Human Services, the Department of Agriculture, the Treasurer's Office, the Office of State Personnel, the Wildlife Commission, the Board of Elections, the Global Transpark Authority, the Department of Cultural Resources, the Administrative Office of the Courts, the Department of Public Safety, State universities, and other State entities named in state Superior Court, Federal Court, or administrative actions. The Group's practice includes jury trials and administrative hearings, as well as class action lawsuits and complex Federal compliance cases. In addition to its obligation to defend State agencies, the Group also provides for the defense of State employees, assigned to Division clients, who have been individually named in civil actions. Finally, the Group's attorneys represent the State in criminal appellate matters.

MAJOR TASKS: Interns will become involved in virtually every aspect of litigation, including: research of state and federal law for use in pending or anticipated actions; investigating claims and evidentiary issues; crafting responsive pleadings; drafting motions; drafting and responding to discovery; preparing pretrial memoranda; trial preparation activities including witness interviews; and, accompanying attorneys to depositions, mediations, hearings, trials, and oral arguments. It is hoped that this broad experience, in conjunction with guidance and counsel from experienced attorneys, will directly benefit the intern whose career ambitions include litigation. In return, the intern will provide a valuable contribution to the Group's various endeavors and resultant impact upon our State's jurisprudence.

N. C. DEPT. OF JUSTICE - ATTORNEY GENERAL'S OFFICE
CONSUMER PROTECTION DIVISION

ELIGIBILITY: Rising 2L or 3L law students

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The Consumer Protection Division enforces the State's unfair and deceptive trade practices act, consumer protection statutes, and antitrust laws, in order to protect consumers in North Carolina from unfair or deceptive practices and illegal scams. The Division files enforcement actions to obtain injunctions to stop individuals or entities from violating North Carolina laws and seeks to obtain monetary refunds for consumers. The Division sometimes files cases in conjunction with other state agencies, the attorneys general of other states, and federal agencies, such as the Federal Trade Commission and the Consumer Financial Protection Bureau. In addition, the Consumer Protection Specialists in the Division handle approximately 22,000 written complaints filed by North Carolina consumers with the Division every year. The Specialists attempt to mediate these complaints through correspondence and successfully resolve over half of the written complaints.

INTERN DUTIES: Summer interns assist in the investigation and prosecution of cases. Their duties may include conducting witness interviews, drafting affidavits, document review, legal research, and drafting civil pleadings, including complaints, motions, supporting briefs, hearing memoranda, and appellate briefs. From time to time, summer interns have also assisted in performing legislative research and bill drafting in connection with legislation involving consumer protection issues.

IN THE PAST: In addition to traditional legal intern projects, some summer interns have enjoyed helping the Division investigate unfair or deceptive practices by making undercover calls and attending meetings or seminars where products or services are "pitched" to the public.

BENEFICIAL EXPERIENCES: The Consumer Protection Division offers summer interns the opportunity to work on a broad range of legal issues. Some substantive areas in which the Division has brought actions and in which summer interns have had an opportunity to learn about include often complex consumer scams and illegal practices in a wide variety of areas, such as false advertising, telemarketing scams, frauds targeted against senior citizens, charitable solicitations, foreclosure assistance, debt settlement, unfair or deceptive automobile sales and lending, off-label pharmaceutical sales, travel scams, for-profit and trade schools, pyramid schemes, and work-at-home scams, among many others.

N. C. DEPT. OF JUSTICE - TRAINING AND STANDARDS DIVISION
CRIMINAL JUSTICE EDUCATION AND TRAINING STANDARDS

ELIGIBILITY: Highly motivated undergraduate in a 2-yr or 4-yr Criminal Justice Degree Program.

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: This Division administers all programs as staff to the North Carolina Criminal Justice Education and Training Standards Commission, to include the regulation of all North Carolina law enforcement officers (with the exception of sheriffs and their deputies), corrections and probation/parole officers, juvenile justice counselors and officers, and all other criminal justice personnel required to be certified by the CJ Commission. The CJ Standards Division assures that all certified officers and personnel meet the minimum standards for employment, training and certification. The Division oversees the Commission-mandated Basic Law Enforcement Training (BLET) and Mandatory In-Service Training courses required of all certified officers. This includes the regulation of such programs as provided by Community Colleges, the North Carolina Justice Academy and local agencies in their delivery of those Commission-mandated course offerings. Instructors teaching in these courses are also subject to regulation and certification by the Division. The Division also administers a Professional Certificate and Service Award Program to award law enforcement and criminal justice officers for their experience, training, education and service in law enforcement and/or criminal justice. The Division administers the Concealed Carry Handgun Instructor Certification and the Retired Qualified Law Enforcement Officer Concealed Carry Program. The Division also staffs the CJ Commission at its quarterly meetings, any committee meetings, and represents the Commission's interests in other venues. The Division provides technical assistance to many agencies in the criminal justice system to aid them in the discharge of program participation and responsibilities. The Division is also empowered to compile data, develop reports, identify needs and perform research relevant to the improvement of these agencies.

INTERN DUTIES: This internship will involve numerous duties in assisting the Division to maintain certification files for delivery systems, instructor certification files, and all records related to the business of the CJ Commission. Assignment of duties will expose the intern to the full scope of Commission regulations.

IN THE PAST: Attend Commission meetings and administrative hearings.

BENEFICIAL EXPERIENCES: Working in the CJ Standards Division allows interns to be exposed to regulations governing law enforcement, corrections and juvenile justice system-wide.

N.C. DEPT. OF JUSTICE - ATTORNEY GENERAL'S OFFICE
CRIMINAL PROSECUTIONS AND FEDERAL HABEAS SECTION

THOSE ELIGIBLE TO APPLY: rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The primary purpose of the Section is to represent the state of North Carolina in the prosecution of criminal cases at trial and/or in post-conviction litigation at the request of District Attorney's Offices throughout the state and upon approval by the Attorney General, pursuant to N.C.G.S. § 114-11.6. Additionally, attorneys in this section also represent the state in upholding lawfully imposed convictions and sentences collaterally challenged by inmates in federal habeas corpus proceedings in federal district courts, the Fourth Circuit Court of Appeals, and the United States Supreme Court. Section attorneys also represent the state in direct appeals in first-degree murder cases before the state appellate courts. Attorneys in this section also provide the following: technical assistance to District Attorneys in all aspects of state prosecution, both at trial and in post-conviction proceedings; assist in prosecutor training across the state; track pending post-conviction capital cases in the state and federal court systems; maintain a clearinghouse of information and research on death penalty issues, statistics, and legislation; formulate strategies and legal positions for the state in both state and federal capital post-conviction litigation; advise the Attorney General on state and federal legislation affecting criminal prosecution, including the imposition of the death penalty in North Carolina; and act as liaison with attorneys general and prosecutors of other states on common criminal prosecution and post-conviction litigation issues. Section attorneys also represent public officials (the Governor, Attorney General, appellate judges at the Supreme Court and Court of Appeals and trial court judges, District Attorneys, magistrates, clerks of court) who are sued for acts committed in their official capacity.

MAJOR TASKS: Section interns will be responsible for myriad tasks which may include: assisting lawyers in the section prepare criminal cases for trial by responding to and filing pretrial motions, handling discovery, securing the attendance of necessary witnesses and other pre-trial tasks necessary to the appropriate disposition of criminal trial litigation; assisting in the litigation of post-conviction Motions for Appropriate Relief by conducting sophisticated legal research; drafting or editing memoranda of law and briefs for filing; assisting attorneys in preparing for evidentiary and non-evidentiary hearings in state superior courts; assisting in the drafting or editing of legal responses and briefs for filing in federal habeas corpus proceedings and assisting in preparing attorneys for evidentiary and non-evidentiary hearings in federal habeas corpus cases before the federal district courts. Interns may assist in obtaining and organizing court records, documents, and exhibits for use in post-conviction litigation and by updating the Section's death penalty database and issue banks. As needed, interns may assist attorneys in drafting appellate briefs and responses to petitions in state appellate courts, and may be involved in preparing attorneys for oral arguments in appellate courts, including observing or participating in internal moot courts. In civil suits against public officials, interns will assist in preparing responsive pleadings and performing additional tasks necessary for the appropriate disposition of civil cases.

BENEFICIAL EXPERIENCES: Section interns will gain a greater understanding of criminal law – both substantive and procedural. Interns will have an opportunity to assist with cases in various state and federal courts and to explore a wealth of complex constitutional issues. Interns will have the opportunity to assist in the real-world context of preparing clear and concise pleadings, motions, supporting memoranda of law for filing in civil and criminal trial cases, criminal appellate briefs, and litigation related to post-conviction motions for appropriate relief and federal habeas corpus proceedings. Interns will receive substantial feedback and edits on work product with the goal of producing documents useful to both the Section and the intern.

N.C. DEPT. OF JUSTICE-ATTORNEY GENERAL'S OFFICE
DIVISION OF MOTOR VEHICLES SECTION

ELIGIBILITY: Rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The Motor Vehicle Section advises the Division of Motor Vehicles, which includes the License and Theft Bureau; a sizeable enforcement agency in North Carolina dedicated to the regulation of automobile dealers and inspections and the investigation and prosecution of vehicle thefts. As a result, the attorneys in this section handle a wide variety of legal matters; both criminal and civil. This section also represents the Division in both state and federal court, as well as the state and federal appellate courts.

INTERN DUTIES:

- 1) Interns will be assigned to work with individual attorneys on a case-by-case basis with assignments including, but not limited to the following: drafting pleadings, discovery, motions, civil and criminal appellate briefs, conducting research and writing memoranda of law.
- 2) The intern may travel with attorneys to motion hearings, trials and other court proceedings regarding DWI related drivers license revocations; as well as any other existing cases as appropriate.
- 3) The intern may be involved in the preparation of cases pending for trial; including, but not limited to drafting trial briefs and formulating appropriate litigation strategies.
- 4) The intern may observe and participate in meetings with personnel from the client agency with regards to policy issues and/or legislative issues affecting the client agency.
- 5) The intern, if eligible, may participate in activities allowable under the Third Year Practice program under the supervision of section attorneys, as deemed appropriate.

BENEFICIAL EXPERIENCES: Interns in the DMV Section will benefit from learning practical skills that will help them in their future practice of law. Interns will work with a broad range of legal issues dealing with almost every facet of law. Furthermore, interns will have an opportunity to observe and potentially participate in courtroom proceedings around NC.

N. C. DEPT. OF JUSTICE - ATTORNEY GENERAL'S OFFICE
EDUCATION SECTION

ELIGIBILITY: rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: Attorneys in the Education Section represent The University of North Carolina and its constituent institutions, the State Board of Education, the Department of Public Instruction, the State Board of Community Colleges, the Department of Community Colleges, the North Carolina State Education Assistance Authority, and the North Carolina School of Science and Math. With respect to its University of North Carolina clients, the Education Section is primarily responsible for litigation. These lawsuits range from claims for breach of contract to alleged civil rights violations in a variety of judicial and quasi-judicial forums, including the Office of Administrative Hearings, state courts, federal courts and due process Committees in the individual constituent universities. Aside from their litigation responsibilities, Education Section attorneys serve as in-house counsel to the State Board of Education and the Department of Public Instruction. In that capacity, attorneys consult with agency officials and assist them with interpreting state statutes and drafting regulations and policies. The Education Section also provides advice and guidance to local educational agencies and boards as well as the general public. Finally, the Education Section also represents the State in criminal appellate matters.

INTERN DUTIES: Members of the Education Section attempt to provide their summer interns with a wide variety of educational experience. Interns will be assigned to work with individual attorneys on a case-by-case basis, with assignments including: identifying potential witnesses and interviewing those witnesses, drafting affidavits in support of motions, drafting motions to dismiss or for summary judgment, attending depositions, drafting discovery and/or drafting responses to discovery, conducting research and writing memoranda of law, attending and assisting with hearings in the Office of Administrative Hearings, state court or federal court, as well as researching and drafting responses to requests for opinions on interpretation of state education statutes.

IN THE PAST: Former interns in the Education Section have gained the following experience: conducting witness interviews, drafting motions to dismiss and motions for summary judgment, drafting deposition questions, drafting arguments for motions, drafting discovery and responses to discovery, drafting trial briefs, drafting jury voir dire questions, drafting jury instructions, drafting petitions for judicial review, drafting opinion letters, drafting pleadings, drafting criminal appellate briefs, participating in attorney strategy sessions, and attending depositions, hearings, trials, and meetings.

BENEFICIAL EXPERIENCES: Interns in the Education Section will benefit from learning practical skills that will help them in their future practice of law. Interns will see the application of law school concepts to the actual practice of law. Interns will be able to hone their career interests by gaining exposure to various legal issues, by gaining exposure to multiple legal tribunals, and by interacting with multiple clients.

ENVIRONMENTAL DIVISION

THOSE ELIGIBLE TO APPLY: rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

COMMISSIONS, COASTAL AND ADMINISTRATIVE SECTION

DESCRIPTION: The Coastal, Commissions, and Administrative (CCA) Section is part of the Environmental Division of the Attorney General's office. The CCA Section provides legal services to boards and commissions of the Department of Environmental Quality (DEQ) and the Division of Coastal Management. The Section also administers the Attorney General's Environmental Enhancement Grant (EEG) Program and provides legal support for DEQ's Collections Program. Representation includes all aspects of civil and administrative litigation, legal advice-giving, and rule-making. The types of litigation include administrative contested cases, injunction cases, collection actions, judicial reviews, appeals, as well as environmental civil actions initiated by or against the State or its agencies in State or federal court. Additionally, the CCA Section's attorneys represent the State in criminal appellate cases and represent DEQ, as the employer, in personnel cases arising under State and federal law.

AIR, WATER AND NATURAL RESOURCES SECTION

DESCRIPTION: The Air, Water and Natural Resources Section is a part of the Environmental Division of the Attorney General's Office. The Section represents the Divisions of Air Quality, Division of Water Resources, and Division of Marine Fisheries of the Department of Environmental Quality (DEQ), the state's primary environmental regulatory agency. The Section also represents the North Carolina Forest Service of the Department of Agriculture and Consumer Services, and the Geodetic Survey of the Department of Public Safety. Representation includes all aspects of civil and administrative litigation, legal advice, and representation during commission meetings. The types of litigation include administrative contested cases, civil injunctive actions, and judicial reviews, as well as environmental civil actions initiated by or against the State or its agencies in state or federal court. The section's attorneys also represent the State in criminal appellate cases.

LAND, GROUNDWATER AND WASTE SECTION

DESCRIPTION: The Waste Management Section is a part of the Environmental Division of the Attorney General's Office. The Waste Management Section provides legal representation to the following Divisions of the Department of Environmental Quality (DEQ), the state's primary environmental regulatory agency – the Division of Energy, Mineral and Land Resources (DEMLR), the Division of Waste Management (DWM), and, in instances related to groundwater regulation and compliance, the Division of Water Resources (DWR). DEMLR includes the following sections and programs: the Land Quality Section, which regulates mining, dams, sediment and erosion control, and stormwater; the Energy Section, which includes oil and shale gas management and regulation, renewables, and implementation of the State Energy Program and Weatherization Assistance Program; and the N.C. Geological Survey, which performs scientific investigations, provides technical assistance and maps the state's geological resources. DWM includes the following sections and programs: Hazardous Waste Section (includes RCRA Program), Solid Waste Section (includes landfills, septage programs, open dumps, compost

facilities, scrap tire Programs), Superfund Section (includes Inactive Sites Program and Dry-Cleaning “DSCA” Program), Brownfield Program, and Underground Storage Tank Section (includes enforcement of, among other things, petroleum-related contamination from all sources, and oversight of the Federal and State Trust Fund programs). Representation includes all aspects of civil and administrative litigation, legal advice-giving, and rule-making. The types of litigation include administrative contested cases, civil injunctive actions, civil cost recovery actions, and judicial reviews, as well as environmental civil actions initiated by or against the State or its agencies in state or federal court. The section’s attorneys also represent the State in criminal appellate cases and represent the State as an employer in personnel actions under the State Personnel Act.

INTERN DUTIES: Interns will assist attorneys by conducting research and writing memoranda of law, drafting documents for administrative contested cases, injunctive actions, judicial review and other litigation and non-litigation matters, and attend conferences, client meetings and hearings.

IN THE PAST: Past interns have researched both environmental and criminal issues; drafted motions, settlement agreements, hearing briefs, and discovery requests; and attended client meetings, depositions, settlement meetings, and hearings. Examples of the activities of interns certified by the Bar to practice under supervision include handling a summary judgment motion hearing in superior court and conducting direct examination in an administrative hearing.

BENEFICIAL EXPERIENCES: Working in the Environmental Division allows interns to gain practical experience, improve their legal research and writing skills, and learn more about the field of environmental law.

HEALTH SERVICE SECTION

ELIGIBILITY: rising 2L or 3L in law school

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The Health Service Section is part of the Administrative Division of the Attorney General's Office. The section advises and represents the Division of Health Service Regulation on a variety of health care issues including the following: the licensure and certification of health care facilities; the investigation of allegations of patient abuse; the assurance that all citizens have access to quality emergency medical care; and, the issuance of certificates of need. The section also represents the State in employment law issues involving employees of state facilities, and represents the State in criminal appellate matters.

SHERIFFS' EDUCATION AND TRAINING STANDARDS

The Division provides technical assistance to many agencies in the criminal justice system to aid them in the discharge of program participation and responsibilities. The Division is also empowered to compile data, develop reports, identify needs and perform research relevant to the improvement of these agencies.

INTERN DUTIES: This internship will perform numerous duties in assisting the Division to maintain certification files for all deputies, detention officers, and telecommunicators, as well as, accreditation files for delivery systems, instructor certification files, and all records related to the business of the Commission. Assignment of duties will expose intern to the full scope of Commission regulations.

In certain circumstances, the attorneys of the section also provide a defense to negligence actions as prescribed by the Defense of State Employees Act, N.C. Gen. Stat. § 143-300.2, *et seq.* Section attorneys also represent the State before the North Carolina Appellate Courts in criminal appeals.

WORKERS' COMPENSATION SECTION

THOSE ELIGIBLE TO APPLY: rising 2L or 3L in Law School

FUNDING STATUS: **Non-paid** internship

DESCRIPTION: The Workers' Compensation Section is part of the Litigation Division of the Attorney General's Office. The Workers' Compensation Section investigates, processes and defends all legal actions brought by State employees against departments, institutions and agencies of the State pursuant to the Workers' Compensation Act, *N.C.G.S. § 97-1 et seq.*, in the North Carolina Industrial Commission, the North Carolina General Courts of Justice, and in federal trial and appellate courts. The section also defends cases pursuant to the Salary Continuation Plan, *N.C.G.S. § 143-166.13* through *§ 143-166.20*, as well as representing state agencies in pursuing subrogation liens pursuant to *N.C.G.S. § 97-10.2*.

Workers' Compensation Section attorneys are involved in extensive litigation. Cases can involve complex factual and legal issues. Cases comprise of multiple physical injuries, psychological injuries, extensive/unusual medical treatment, multiple issues, asbestosis claims, mold claims, serious occupational disease claims, death claims, and post-traumatic stress disorder. Section attorneys also represent the State in the North Carolina Appellate Courts handling criminal appeals.

INTERN DUTIES: Interns will work with individual attorneys on a variety of cases. Selected candidates will be provided the opportunity to engage in all manners of litigation related duties, including: drafting pleadings, motions, discovery, medical narratives, settlement agreements, Industrial Commission forms, and trial and appellate briefs; identifying and contacting Third Party Adjusters and potential witnesses; conducting research and writing memoranda of law. Interns will also have the opportunity to attend mediations, witness interviews, depositions, Deputy Commissioner hearings and Full Commission hearings.

BENEFICIAL EXPERIENCE: Because of the extensive amount of litigation involved in Workers' Compensation, interns will get experience in all aspects of litigating a claim from initial case analysis through appellate practice. Additionally, they will have the opportunity to hone their brief writing skills on both civil and criminal cases in the lower courts and the Court of Appeals.
