

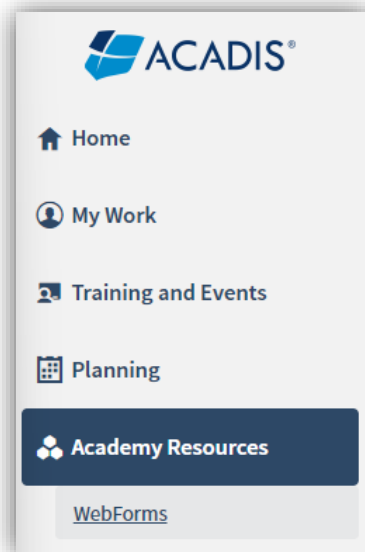

Requesting RLEO Certification Renewal

Start by logging into the [North Carolina Justice Training & Certification Portal](#). If have ever been previously certified in NC as a RLEOF, CCH Instructor or Law Enforcement Officer, but have never accessed your Portal account, please email CJAcadisHelp@ncdoj.gov and include your full name, date of birth, and current email address. Please mention in the email that you are RLEOF and are trying to gain access to the Portal.





CCH Certificate Request Form – For CCH Instructor Use Only	Concealed Carry Handgun Instructors use this form to purchase blank CCH Certificates.
CCH Instructor Certification Initial Application	Prospective Concealed Carry Handgun Instructors use this form to request initial certification issuance.
CCH Instructor Certification Renewal Request	Current Concealed Carry Handgun Instructors use this form to request certification renewal.
Data Update form	to update SSN and DOB within Acadis
Edneyville Range Operation	Use this form to open and close the range. Also used to report maintenance needs and caliber and round count.
FTA - BAT Mobile Unit Request - Traffic Safety Presentation	Request a BAT Mobile unit for a Traffic Safety Presentation.
FTA - Intox EC/IR II Permit Card Request	Replacement Intox permit card request form.
FTA - SFST Instructor Candidate WebForm	This WebForm is to be used only by North Carolina SFST Instructor Candidates who have completed an approved SFST Instructor Development Course within the preceding six months.
FTA - SFST Instructor Recertification WebForm	This WebForm is to be used only by North Carolina SFST Instructors seeking recertification. This form is to be used after the SFST instructor has completed the required SFST Instructor Refresher training.
FTA - SFST/IDD Training Request Form	This WebForm is to be used by certified NC SFST Instructors to submit DWI Detection & Standardized Field Sobriety Testing (SFST), SFST Refresher, and Introduction to Drugged Driving Class Request(s) to FTA.

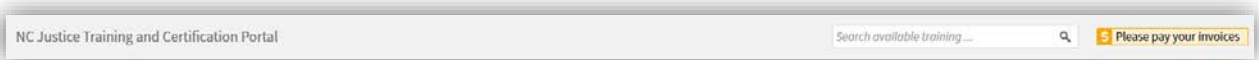
