I. CALL TO ORDER

Chair Cloninger declared a quorum with eight Sheriff Commissioners present.

Interim Director Sirena Jones read the Ethics Reminder.

II. <u>12 NCAC 10B .0303</u> Fingerprint Criminal History Records Check Sirena Jones

Interim Director Sirena Jones addressed the commission Members regarding the 12 NCAC 10B .0303 stating there was discussion at our last meeting in March 2022. There was some confusion on how the rule was written and the Commission asked to send it to the rules advisory group for more clarification.

The rules advisory group meet via TEAMS on March 23, 2022 with both Sheriff's Commission and Criminal Justice Commission and the matter was addressed. The language was changed to an applicant for certification or as a Justice Officer may not perform any action requiring certification by the commission prior to the date on which the employing agency receives the report of the result of the criminal history records check utilizing fingerprints.

Chair Cloninger asked the Sheriffs' Commission Members if there were any questions. Negative response.

A **MOTION** was made by Sheriff Alan Norman to accept Rule (12 NCAC 10B .0303); Seconded by Sheriff Alan Jones. **MOTION CARRIED**.

III. <u>12 NCAC 10B .0803 Reports/Detention Officer Cert Course Presentation/Completion</u> Sirena Jones

Interim Director Sirena Jones addressed the Sheriffs' Commission Members and stated that this rule is amending the reading grade level for the Detention Officer and Telecommunicator Courses. During the December Commission, it was voted to remove the requirements to collect the data as well as requiring a reading grade level for both Detention and Telecommunicator Officer Courses.

Chair Cloninger asked the Sheriffs' Commission Members if there were any questions. Negative response.

A **MOTION** was made by Sheriff John Ingram to accept Rule (12 NCAC 10B .0803); Seconded by Sheriff Ricky Oliver. **MOTION CARRIED**.

Chair Cloninger asked Sirena Jones to give and update for the two DOCC programs Sheriff Burkehead had requested to run at the Durham County Sheriff's Office. Ms. Jones stated that the proposed rule was sent to the Rules Review Commission; it was filed on March 25, 2022 and the earliest effective date could be August 1, 2022.
