Sheriff Cloninger asked the visitors to introduce themselves. Sheriff Cloninger stated that it appeared that most visitors were here to speak on the rules that requires training before the appointment and moved this item up on the agenda. The rules address the requirement to complete basic training prior to becoming appointed. Currently the rule allows the Sheriff's Office to appoint an individual to work as a Deputy Sheriff, Detention officer and Telecommunicator and allows the individual one year from that appointment date to complete the necessary training to obtain certification.

The new drafted rule would not allow Sheriff's to appoint individuals who did not have the necessary training. The sheriffs who came to speak related that due to the climate of law enforcement, the new rule, if passed, would hurt all 100 Sheriff's offices and take away their power to hire an individual on the spot. Representatives from multiple Police Departments and Telecommunicator centers also related that changing the rule would hinder recruitment and the running of communication centers. The Sheriffs in the audience also stated that the Criminal Justice Standards Commission was different from the Sheriffs' Standards Commission and asked that the Commission reconsider the rule.

Sheriff Cloninger asked if there was a motion for the proposed rule changes.

A **MOTION** was made by Sheriff Alan Norman to reconsider the rule and table it for more discussion until September 2023 meeting for a vote; Seconded by Sheriff Jack Smith.

Sheriff's Shelton White, Mike Roberson, Ricky Oliver, Alan Jones, David Mahoney, and Ed McMahon oppose the motion. 4 to 6 vote **MOTION FAILS.** 

A **MOTION** was made by Sheriff Mike Roberson to delay implementation of the proposed rule until January 1, 2024; Seconded by Sheriff Ed McMahon. Sheriff Roberson then amended his motion to delay the implication of the rule until July 1, 2024; Seconded by Sheriff McMahon. **MOTION CARRIED**.

Chairman Cloninger stated that the rule was tabled until 2024 and to send comments regarding it to Director Richard Squires with the Sheriffs' Standards Division. He also stated that division staff would keep all the sheriffs updated with the proposed rule changes.

### The Sheriffs' Leadership Institute will be held Sunday, November 13 through Friday, November 18, 2022 in Chapel Hill and will include at least 30+ newly elected sheriffs, some of whom have

The Chief Deputies' Leadership Institute Advisory Group met recently to identify the topics that need to be included in this training program that is scheduled to be offered in 2023.

#### \*North Carolina Justice Academy [Attachment #2] Trevor Allen

Director Trevor Allen addressed the Sheriffs' Commission members and thanked them for the opportunity to present the North Carolina Justice Academy updates. Mr. Allen provided the Sheriffs' Commission with a summary of news and events including personnel updates, as follows:

• There are currently three (7) positions that are at various stages of the recruitment process. We have hired several Candidates selected for vacant positions and looking forward to filling the new created positions by the legislation.

Director Allen provided some current NCJA training statistics:

- In-person Courses: 379
- In-person Students: 9,223
- On-line Courses: 169,381
- Instructor Update completions (1 hour requirement): 6,179
- SRO Update: 2,036

Director Allen also reported on new courses and events. Courses currently being delivered include training in Leadership Training and Field Force Operations. The synopsis of all the courses can be found on the attachment.

#### **BLET Curriculum Updates [Attachment #3]**

#### Alex Gazaway

Mr. Alex Gazaway provided an update to the Commission regarding the BLET curriculum. Mr. Gazaway stated all 39 lesson plans have been drafted. The initial pilot site has been selected: Fayetteville Technical Community College is to begin in January 2023. The North Carolina Justice Academy staff have completed the first draft for the Course Management Guide and end-of-topic tests for the pilot schools, which is also being reviewed by Criminal Justice Standards Divisions staff. The synopsis of the updates can be found on the attachment.

A **MOTION** was made by Sheriff Ricky Oliver to approve the rule changes for 12 NCAC 10B .1302; Seconded by Sheriff Alan Jones.

#### **\*Probable Cause Committee**

Sheriff David Mahoney reported that the Probable Cause Committee met on September 15, 2022. During that session, the Committee reviewed a total of Thirty-five (35) cases. Five (5) cases were closed pursuant to the Consolidated Probable Cause Policy.

One (1) case was postponed until the November 2022 meeting. No Probable Cause was found in Fifteen (15) cases. Probable Cause was found in thirteen (13) cases with five (5) of those cases resulting in Consent Agreements. The four (4) Consent Agreements were signed and are presented for approval today.

Three consent agreements were signed from the June meeting and those were presented. Chair Cloninger asked the Commission members if there were any questions. There were none.

**Detention Officer Certification Course Revision** 

Ms. Amanda Stephenson provided an update to the Commission regarding the DOCC curriculum. Ms. Stephenson stated DOCC Advisory Group is meeting tomorrow September 23. The group will be reviewing revisions for the January 2023 rollout due to the replacement of NCAWARE with eWarrants, as well as progress in the task analysis.

She stated that two new Advisory Group members have been added, Captain Lori Pierce from Union County Sheriff's Office and Lt. Timothy Case from Polk County Sheriff's Office. She explained that tasks identified in the task analysis dealing with Subject Control and Physical Fitness have been presented to those advisory groups for input.

#### **Telecommunicator Certification Course Update**

Ms. Susan Gillis provided an update to the Commission regarding the TCC curriculum. She stated that the Justice Academy will be offering the pilot course on November 6, 2022 and they are looking at a Mid-April/May 2023 rollout.

The Commission Curriculum Approval for TCC will be discussed at the next Sheriffs' Commission meeting. Additionally, the New Curriculum for TCC will begin on January 1, 2023 and the new curriculum for DOCC training working with Durham County will roll out in August 2023. She also provided a copy of proposed rule changes for 12 NCAC 10B .1302 Telecommunicator Certification Course.

#### **V. DIVISION REPORT**

#### **Richard Squires**

Director Squires presented the Division Report to the Sheriff's Commission.

The Division continues to fill vacant positions. Since the last meeting, the Division has hired, effective August 1, 2022, Jasmine Caldwell as an Administrative Specialist. The Division still has two vacant Administrative Specialist positions. These positions are critical positions that support the processing of applications. The Division is in the process of filling both positions.

#### \*Accreditation

Both Commissions through the NC Law Enforcement Accreditation (NCLEA) Committee has worked to establish guidelines and minimum standards for the accreditation program. Staff sent to the Commissioners a draft of the NCLEA Program Manual and NCLEA Standards. Please send any recommended edits to me. Legal is still reviewing and making technical changes to the documents. Once all changes have been made the documents will be brought back to the next meeting for approval.

Director Squires noted that the Committee approved a pilot program consisting of agencies that are CALEA certified and agencies that are not CALEA certified. On August 8, 2022, the NCLEA Committee held a meeting and approved the awarding of state accreditation of the Brunswick County Sheriff's Office, NC State University Police Department, Wilmington Police Department, and the Roxboro Police Department

#### \*Rapback Program

As discussed at the last meeting, the Sheriffs' Standards Division and the Criminal Justice Standards Division requested funding to implement this program. This funding request was not included in the budget. Both Divisions continue to work with Acadis and the SBI to implement the program. Rapback will require all individuals who are currently certified to be fingerprinted (live scan) between January 1, 2023 and May 31, 2023.

#### \*Legal Permanent Residents as Law Enforcement Officers

At their last meeting, the Criminal Justice Commission heard information on the advantages of allowing legal permanent residents to serve as law enforcement officers. Currently the rules only allow US citizens to be certified as justice officers. The Criminal Justice Commission asked staff to do additional research and to return to their November meeting with a request for rulemaking authority. Since this is a minimum standard, any changes to this requirement would have to be approved by both Commissions. Director Smythe spoke on this subject.

#### VI. ACTION ITEMS

#### **Richard Squires**

Director Squires presented the Administrative Rules Action Items to the Sheriffs' Commission.

#### \* Class B Misdemeanor Manual

Director Squires reported that the Class B Misdemeanor Manual Advisory Group met via TEAMS on July 22, 2022. The recommendations were presented and approved to the Criminal Justice Standards Commission on August 12, 2022. They voted to include the attached list of changes to the manual. Commissioner Sheriff Shelby White and Commissioner Jamie Markham are your representatives in this group. This group also includes representation from the CJ Commission, as well as legal counsel and Division staff. I would like to recommend that the Commission approve the listed changes to the manual.

A motion was made by Sheriff Shelton White to approve the proposed rule changes; seconded by Sheriff Mike Roberson. **MOTION CARRIED** 

#### \* Administrative Rules

Director Squires reported that at your last meeting you adopted several rules that are now in the rule making process. A chart is provided to show the status of those rules. Most of the rules go into effect July 1, 2023. The DOCC rule for the shortened standalone course and the DOCC rule to provide credit for BLET completion is scheduled to go into effect on November 1, 2022. The public hearings have taken place for these rules with no one from the regulated public being present. Staff has received correspondence from the regulated public on the rules requiring training before being appointed, with the majority not being in favor of the proposed change. The Commission will need to vote to approve the rules.

The first group of rules are proposed to be effective on January 1, 2023. The below group of rules are proposed changes to minimum standards required by SB 300.

A motion was made by Sheriff Mike Roberson to table the proposed rule changes with the exception of 10B .0304 – Medical Examination; seconded by Sheriff Ricky Oliver. **MOTION CARRIED** 

#### \* Responsibilities: School Directors, Detention Officer Course – 12NCAC 10B .0704

Director Squires reported that when the Commission proposes a rule change, this opens the whole rule for review by the RRC and not just the proposed changes. During the review, the RRC objected to the rule, finding that the agency was exceeding its authority, and the rule was not clear and ambiguous, as noted in parts 1 & 3 of the RRC staff's opinion. NCGS 150B-21.12 addresses the two actions available to the Commission regarding the RRC's objection of the rule, which are (1) change the rule to satisfy the Commission's (RRC) objection and submit the revised rule to the Commission (RRC), and (2) submit a written response to the Commission (RRC) indicating that the agency has decided not to change the rule.

A motion was made by Sheriff Mike Roberson to not change the proposed rule; seconded by Sheriff Retired David Smith. **MOTION CARRIED** 

#### \* Proposed Future Commission Dates

Director Squires reported that he received a request to change the December 1<sup>st</sup>, 2<sup>nd</sup> meeting dates to November 28<sup>th</sup>, 29<sup>th</sup>. This was due to members not being available for the December dates.

He also provided the below listed dates for 2023:

A **MOTION** was made by Sheriff Jack Smith to discuss personal matters in closed session; seconded by Sheriff Alan Jones. **MOTION CARRIED** 

A **MOTION** was made by Sheriff Shelton White to enter open session; seconded by David Mahoney. **MOTION CARRIED** 

Mr. Squires summarized the closed session matters as follows:

The Avery County Sheriff's Office submitted a request to the Commission concerning several detention officers. Due to staffing issues, they will not complete basic training during their probationary period. Sheriff Danny Phillips has submitted letters on Steve Lathern Williams II, Thomas Dewey Lyons and John Adam Carver for your consideration.

A **MOTION** was made by Sheriff Allan Jones to grant the three Avery County Sheriff's Office DOCC training extension as summarized by Mr. Squires; Seconded by Sheriff Jack Smith. **MOTION CARRIED** 

The Ashe County Sheriff's Office submitted a request to the Commission concerning detention officer Courtney Miller Watson not being able to complete her DOCC course on time due to a SCAT deficiency. The agency is asking for an extension for her to complete DOCC and allow her to receive credit for the portion of DOCC she has completed.

A **MOTION** was made by Sheriff Allan Norman for Ms. Watson to receive no credit for her partial DOCC class and grant an extension for her to complete the class by June 1, 2023; Seconded by Sheriff Mike Roberson. **MOTION CARRIED** 

The Durham County Sheriff's Office submitted a request to the Commission concerning Shownnie Felder Whitfield detention officer certification. She was scheduled to attend DOCC training but could not attend. The agency is requesting an extension until November 16, 2022 for her to complete the training through the Wake County Sheriff's Office.

A **MOTION** was made by Sheriff Jack Smith to grant the extension; Seconded by Retired Sheriff David Smith. **MOTION CARRIED** 

The Surry County Sheriff's Office submitted a request to the Commission concerning Jonathan Tate Woods certification. Sheriff Hiatt is requesting that the commission reinstate/backdate his certification to allow him to hold his certification in a non-gun carrying status and the Sheriff is also requesting that the Commission waives his training that was required during this time.

A **MOTION** was made by Sheriff Mike Roberson grant Mr. Wood with 6 months credit of training; Seconded by Sheriff Ricky Oliver. **MOTION CARRIED** 

The Northampton County Sheriff's Office submitted a request to the Commission concerning Michael Darnell Squire. The Sheriff has asked for a 4-month extension for Mr. Squires to complete the classroom part of BLET and pass the state exam by November 15.

A **MOTION** was made by Sheriff Alan Norman to grant the 4month extension; Seconded by Retired Sheriff David Smith. **MOTION CARRIED** 

With the ending of the Governor's emergency order, the Director requested Bob Pickett, Commission Legal Counsel, to research if the Commission can still hold meetings remotely, if needed. He stated that the answer would be yes.

> A **MOTION** was made by Sheriff Shelton White to authorize staff a revision of the bylaws in which this pertains; Seconded by Sheriff Alan Norman. **MOTION CARRIED**

Director Richard Squires asked for approval for staff to order badges for commission members.

A **MOTION** was made by Sheriff Alan Norman to approve the badge order for the commission; Seconded by Sheriff Alan Jones. **MOTION CARRIED** 

Director Richard Squires asked for approval for staff to work on a resolution of appreciation for all commission members who would be leaving after the next meeting.

A **MOTION** was made by Sheriff Mike Roberson approve the resolution of appreciations; Seconded by Sheriff Jack Smith. **MOTION CARRIED**

## Field Force Operations (FFO) (PER-200)

The three-day Field Force Operations (FFO) course provides law enforcement and security officers with instruction in protest types and actions, legal considerations, responsibilities of mobile field force teams, and crowd-control methods. The course culminates with a series of hands-on activities that allow responders to practice all of the learned skills (baton-holding positions, mass-arrest procedures, and riot-control formations) in a realistic context.

Below are some, but not all, of the critical skill sets learned during this training program:

- Identify considerations of a protest situation.
- Use equipment to control crowds.
- Execute positions in crowd-control squad formations.
- Position yourself within a mass-arrest team to apprehend, search, and detain a subject.

Prerequisites: To be eligible for the course, the student must successfully complete the following courses: AWR-160, WMD/Terrorism Awareness for Emergency Responders; IS-100.b, Introduction to the Incident Command System or any of the available ICS-100 series; and IS-700.a, National Incident Management System (NIMS), An Introduction. Students must be physically capable of standing for long periods; walking and marching for long periods; employing a baton in the performance of crowd-control actions; and performing lifts and carries required in the performance of mass-arrest carries. Exceptions to any of the above prerequisites may be granted on a case-by-case basis at the discretion of the CDP Registrar.

(a) The Commission hereby accredits as its telecommunicator certification training program, the 47-hour Telecommunicator Certification Course developed by the North Carolina Justice Academy.

(b) Each Telecommunicator Certification Course shall include the following identified topic areas and approximate minimum instructional hours for each area:

(c) Consistent with the curriculum development policy of the Commission as published in the "Telecommunicator Certification Course Management Guide", the Commission shall designate the developer of the Telecommunicator Certification Course curricula and such designation shall be deemed by the Commission as approval for the developer to conduct pilot Telecommunicator Certification Courses. Individuals who complete such a pilot Telecommunicator Certification Course offering shall be deemed to have complied with and satisfied the minimum training requirement.

(d) The "Telecommunicator Certification Training Manual" as published by the North Carolina Justice Academy shall be used and shall automatically include any later amendments and editions of the incorporated matter to apply as the basic curriculum for the Telecommunicator Certification Course. Copies of this manual may be obtained by contacting the North Carolina Justice Academy, Post Office Box 99, Salemburg, North Carolina 28385-0099.

(e) The "Telecommunicator Certification Course Management Guide" as published by the North Carolina Justice Academy shall be used and shall automatically include any later amendments, editions of the incorporated matter to be used by certified school directors in planning, implementing and delivering basic telecommunicator training. The standards and requirements established by the "Telecommunicator Certification Course Management Guide" must be adhered to by the certified school director. Each certified school director shall be issued a copy of the guide at the time of certification at no cost to the accredited school.

(f) Institutions may offer to deliver the Telecommunicator Certification Course after the Commission has approved the institution's pre-delivery report documenting who will be teaching the blocks of instruction for each course offering.
