Chair Jones announced that a quorum was present.

Chair Jones noted that Mr. Chris Brooks, Assistant Attorney General, would serve as the Commission Legal Counsel. Mr. Brooks read the ethics statement to the Commission members and reminded everyone that both the Petitioner and the Respondent would be limited to 30 minutes of oral argument.

Chair Jones welcomed everyone to the meeting. Sheriff Jones then asked visitors to stand and introduce themselves.

Chair Alan Jones asked Alex Radford to administer the oaths for Sheriffs' Van Shaw, Lowell Griffin and Donald Brown who were all newly appointed to the Sheriffs' Commission.

Since Sheriff Alan Jones previously served on the Probable Cause committee when these cases were heard, Sheriff Jones recused himself as the Chair for this meeting and Vice Chair Jack Smith presided over the Final Agency Decisions.

II. FINAL AGENCY DECISION

Benjamin Zellinger

*Monty Ray Devenport III

Mr. Benjamin Zellinger addressed the Sheriffs' Commission Members and stated that Mr. Monty Devenport III is seeking to hold his certification as a Detention Office with the Onslow County Sheriff's Office. Mr. Benjamin Zellinger presented oral arguments regarding the case against Mr. Monty Devenport III. He presented that the petitioner while certified as a justice officer committed the Class B misdemeanor offense of Assault on a Female and he failed to notify the commission within five business after he was charged with the misdemeanor offense.

Vice Chair Smith asked the Commission if there were any questions. Sheriff's Donald Brown, Jeff Crisco, Van Shaw, and Lowell Griffin questioned Mr. Devenport. The petitioner's attorney, Michael McGuinness presented oral arguments regarding the case.

Attorney Michael McGuinness addressed the commission and stated that he hopes the commission adopts the administrative law judge's recommendation of one year of probation for his certification.

Mr. Devenport was recognized and addressed the Commission. He stated that he did not fail to report the charge to the commission on purpose because during that time his brother had passed away and will take responsibility for his failure to report.

Vice Chair Smith asked questions of Major Thomas, and Captain Spearman, who were present to speak regarding Mr. Devenport's character. They all spoke highly of Mr. Costner.

A **MOTION** was made by Sheriff Terry Johnson to enter closed session; seconded by Sheriff Alan Norman. **MOTION CARRIED**.

A **MOTION** was made by Sheriff Terry Johnson to enter open session; seconded by Sheriff Alan Norman. **MOTION CARRIED.**

A **MOTION** was made by Sheriff Terry Johnson in the matter of Mr. Monty Ray Devenport III; to adopt counsel's proposed final agency decision that Mr. Devenports justice officer certification be suspended for a period of Five (5) Years; however in lieu of suspension, Mr. Devenport's justice officer certification is stayed for Six (6) months beginning September 23, 2022; seconded by Sheriff Alan Norman. **MOTION CARRIED**. *Archie Quintana

Mr. Benjamin Zellinger addressed the Sheriffs' Commission members and stated that Mr. Archie Quintana is a certified justice officer with the Washington County Sheriff's Office. In his oral argument he stated that this case has been continued from the September 2022 Commission Meeting and that Department of Justice received a draft for Probable Cause notice to start a contested case; however, Department of Justice filed a contested case notice with the Office of Administrative Hearing prior to Probable Cause notice being sent. The Department of Justice requests that the contested case be dismissed to allow normal process. The Administrative Law Judge's proposal for decision based on the foregoing Findings of Fact and Conclusions of Law, recommends that the Commission motion to dismiss is granted, and this contested case is dismissed without prejudice.

Mr. Quintana was not present for the Final Agency Decision; However, Mr. McGuinness had his oral argument and asked the commission to recommend the ALJ's proposal for dismissal.

Vice Chair Smith asked the Commission if there were any questions. Negative response.

A **MOTION** was made by Sheriff Jeff Crisco to enter a closed session; seconded by Sheriff Terry Johnson. **MOTION CARRIED**.

IV. FINAL AGENCY DECISION

Kirstin Greene

*Scottie Lynn Deese

Ms. Kirstin Greene addressed the Sheriffs' Commission members and stated that Mr. Scottie Lynn Deese holds justice officer certification with the Robeson County Sheriff's Office. In her oral argument she stated petitioner obtained certification with the Sheriffs' Office in 2020. The alleged rule violation is he knowing made misrepresentation on his application required for certification. He was charged with Commission of a felony; burning of personal property when he was under the age of 18 and Convicted of a felony of personal property.

In Ms. Greene's oral argument, she recommends to the Commission to reverse the recommendation in the proposed Final Agency Decision to revoke his justice officer certification permanently and that the commission take no action since the felony was expunged. As for the material misrepresentation, Ms. Greene recommends his certification be placed on probation for 5 years.

Mr. Barry Hinline, Mr. Deese Attorney, had his oral argument and asked the commission to dismiss the case since he was 18 years old at the time, he committed the crime.

Ms. Deese asked the commission to dismiss the case since it was so long ago and that since he went into the military he has changed and wants to make a difference in his community.

Vice Chair Smith asked the Commission if there were any questions. The Commission asked Mr. Deese several questions regarding his case.

A MOTION was made by Sheriff Van Shaw in the matter of Scottie Lynn Deese; that we Adopt proposed counsels Final Agency Decision to revoke permanently for his prior felony conviction, and for a period of Five (5) Years due to violation of 12 NCAC 10B.0204(c)(1) and (2), seconded by Sheriff Jeff Crisco. V. FINAL AGENCY DECISION

*Matthew Scott Craft

Ms. Kirstin Greene addressed the Sheriffs' Commission members and stated that Mr. Matthew Scott Craft holds justice officer certification with the Person County Sheriff's Office. In her oral argument she stated an administrative hearing was held on October 6, 2022, before administrative Law Judge, John C. Evans regarding whether Petitioner's justice officer certification should be denied based on the grounds that Petitioner committed a Class B Misdemeanor offense of Assault on a Female. Mr. Craft was not present at the decision.

On December 15, 2022, Judge Evans filed his Proposal for Decision, and recommended that Petitioner retain his justice officer certification.

Vice Chair Smith asked the Commission if there were any questions. Negative Response.

A **MOTION** was made by Sheriff Alan Norman in the matter of Matthew Scott Craft; that we Adopt proposed counsels Final Agency Decision, that his certification is revoked indefinitely for a lack of good moral character required for all justice officers and for a period of Five (5) Years for the commission of a Class B Misdemeanor Assault on a Female, seconded by Sheriff Lowell Griffin. **MOTION CARRIED**. VI. FINAL AGENCY DECISION

*George Keith Sizemore

Ms. Kirstin Greene addressed the Sheriffs' Commission members and stated that Mr. George Keith Sizemore holds justice officer certification with the Yadkin County Sheriff's Office. In her oral argument she stated petitioner Alleged rule violation class b mis nc10b.0204D damage to personal property and Failure to report NC10b0204B. Mr. Sizemore was not present at the Final Agency Decision.

Based on the foregoing Findings of Fact and Conclusions of Law, it is hereby ordered that petitioner's certification Not Be Denied and instead be placed in a probationary status for two years on condition that his not violate commission rules or commit a criminal offense.

Vice Chair Smith asked the Commission if there were any questions. Negative Response.

In her oral argument she stated the petitioner had failed to comply with interlocutory orders and for failure to prosecute the matter was dismissed with prejudice. Based on this, his certification is revoked for a period of Three (3) years.
