BY SHERIFF'S STANDARDS

An administrative hearing was held on October 9, 2023, before Administrative Law Judge Stacey Bice Bawtinhimer regarding whether Petitioner's justice officer certification should be denied for the commission of the felony offense of Larceny/Remove/Deactivate Component again

Belk's Department Store. On November 15, 2023, Judge Bawtinhimer filed her Proposal for Decision, and recommended that the Commission REVERSE its intended revocation of Petitioner's justice officer certification. Counsel for the Commission has submitted Exceptions to the Proposal for Decision and a Proposed Final Agency Decision for your review.

TODD THOMAS

An administrative hearing was held on January 9, 2024, before Administrative Law Judge John C. Evans regarding whether Petitioner's justice officer certification should be suspended based upon a positive drug screen. On February 15, 2024, Judge Evans filed his Proposal for Decision, and recommended that Petitioner's justice officer certification be REVOKED for FIVE (5) YEARS; however, that revocation be suspended and Petition be placed on PROBATION for a period of FIVE (5) YEARS due to extenuating circumstances brought out at the administrative hearing, on the condition that during that period of probation, Petitioner not violate any law (other than infractions) of this state or any other state, any federal laws, or any rules of this Commission. Counsel for the Commission and Counsel for Petitioner have submitted Exceptions to the Proposal for Decision. Counsel for the Commission has submitted a Proposed Final Agency Decision for your review.

JUNIOR THOMPSON

An administrative hearing was held on October 19, 2023, before Administrative Law Judge Samuel K. Morris regarding whether Petitioner's justice officer certification should be denied for the commission of the Felony of Bigamy. On December 4, 2023, Judge Morris filed his Proposal for Decision, and recommended that Petitioner's justice officer certification be **DENIED PERMANENTLY** for committing the Felony offense of Bigamy. Counsel for the Commission has submitted **Exceptions to the Proposal for Decision** and a **Proposed Final Agency Decision** for your review. Petitioner emailed Counsel for the Commission seeking to withdraw his petition due to medical reasons.
