

## 12 NCAC 10B .0403 Probationary Certification Requirement

# **Public Hearing**

### **Reason for rule change:**

The Sheriff's Commission voted to not require sheriff deputies to complete Basic Law Enforcement Training (BLET) prior to taking their oath of office. The Commission voted to return to the previous requirement that BLET be completed during their probationary period.

#### **Instructions for Oral and Written Comments**

"Public Comment" is defined by NCGS 150B-21.3A(a)(5) as a written objection to all or part of a rule. Additionally, pursuant to NCGS 150B-21.3A(c)(2), in order for the Rules Review Commission to determine whether the public comment has merit, the public comment must address the specific substance of the rule and address any of the standards of Commission review, as set forth in NCGS 150B-21.9(a).

#### **Procedure for Subjecting a Proposed Rule to Legislative Review:**

If an objection is not resolved prior to the adoption of the rule, a person may also submit written objections to the Rules Review Commission. If the Rules Review Commission receives written and signed objections in accordance with G.S. 150B-21.3(b2) from 10 or more persons clearly requesting review by the legislature and the Rules Review Commission approves the rule, the rule will become effective as provided in G.S. 150B-21.3(b1). The Commission will receive written objections until 5:00 p.m. on the day following the day the Commission approves the rule. The Commission will receive those objections by mail, delivery service, hand delivery, or facsimile transmission. 18	(1)	If the applicant for probationary certification is authorized by the sheriff to carry a firearm pursuant
19		to the provisions of 12 NCAC 10B .2104, Rule .2104 of this Subchapter, the employing agency shall
20		submit evidence of satisfactory completion of the employing agency's in-service firearms training
21		and requalification qualification program pursuant to 12 NCAC 10B .2000 and .2100; Section .2100
22		of this Subchapter; or
23	(2)	If the applicant for probationary certification is not authorized by the sheriff to carry a firearm
24		pursuant to the provisions of 12 NCAC 10B .2104, Rule .2104 of this Subchapter, the employing
25		agency shall notify the Division, in writing, that the applicant is not authorized by the sheriff to
26		carry a firearm.
