V. <u>CIVIL UNREST POLICY</u>

Session Law 2023-6 (HB40) requires the Department of Justice in consultation with the Sheriffs' Standards Division, the Criminal Justice Standards Division, and the NC Department of Public Safety to develop a model law enforcement agency protest and engagement policy and submit it to the legislature. After consulting numerous policies, DOJ has identified the Crowd Management Policy created by the International Association of Chiefs of Police (IACP) as the best starting point for law enforcement agencies to use in developing their agency protest response and engagement policies. We are asking the Commission to consider approving a draft Civil Unrest Policy.

VI. OPERATION CATCHUP

Director Squires addressed the Commission and stated that a project has begun with collaboration with Sheriffs' Standards Certification team and the North Carolina Sheriffs' Association called Operation Catchup. The purpose of this project is to help relieve some of the buildup of certification applications with all the Sheriff's Office and working with individual agencies to insure everyone is on the same page with getting their officers certified.

The Chair recognized Mr. Eddie Caldwell who related that during the review of applications an issue was identified with the Psychological Screening submission requirements for older applications that were received prior to February 1, 2024. On that date, a rule change requiring a submission of an unredacted psychological became effective. He requested that the Commission consider approving these earlier submitted psychological screening screenings if they were submitted prior to the rule change on February 1, 2024.
