#### I. <u>CALL TO ORDER</u>

Chairman Jones asked Alex Radford to administer the oath for newly appointed member Sheriff Chip Hughes.

#### III. APPROVAL OF MARCH FAD MINUTES

**Sheriff Alan Jones** 

Chairman Jones requested a motion to approve minutes for the March 21, 2024, Final Agency Decisions.

A **MOTION** was made by Sheriff Alan Norman to approve the minutes from the March 21, 2024, Final Agency Decision meeting; seconded by Sheriff Jack Smith. **MOTION CARRIED** 

#### IV. FINAL AGENCY DECISION

Joy Strickland

#### \*Israel Solorzano Benitez

Mr. Benitez was present for the proceedings. He was accompanied by his Attorney Barry K. Henline and his Captain, Will Thurston. Mrs. Joy Strickland presented oral arguments regarding the case against Benitez. She presented that the petitioner is an applicant for deputy sheriff certification through the Duplin County Sheriff's Office. Based on the information that came before the Commission's Probable Cause Committee, they found probable cause to deny Petitioner's justice officer certification. On or about November 14, 2026, Petitioner committed the felony offense of Larceny Remove/Destroy/Deactivate Component by removing an anti-theft device from an item in the Belk's Department Store. The Petitioner was arrested and charged with Felony Larceny from a Merchant.

The petitioner's attorney, Barry K. Henline presented oral arguments regarding the case. Mr. Henline argued that the Petitioner was sixteen at the time of the incident. The offense was later expunged. He agrees with the Administrative Law Judges Decisions and hopes that the Commission take no action to deny his certification.

Captain Will Thurston also spoke highly of Mr. Benitez and hopes that the Commission consider what was said about Mr. Benitez.

Chairman Jones asked the Commission if there were any questions.

A **MOTION** was made by Sheriff Lowell Griffin to enter closed session; seconded by Sheriff James McVicker. **MOTION CARRIED** 

A MOTION was made by Commissioner Marc Nichols to enter open session; seconded by Sheriff James McVicker. MOTION CARRIED

A **MOTION** was made by Sheriff Alan Norman in the matter of Israel Solorzano Benitez; due to Session Law 2023-56, the Commission is taking **NO ACTION to DENY** his certification; seconded by Sheriff Van Shaw. **MOTION CARRIED.** 

#### \*Todd Thomas

Mr. Thomas was present for the proceedings while also accompanied by Lt. Cody Houser with Robeson County Sheriff's Office. Mrs. Joy Strickland presented oral arguments regarding the case against Mr. Thomas. She presented that the petitioner is currently a certified deputy sheriff with the Robeson County Sheriff's Office. The petitioner was involved in a vehicle collision with a deer in 2022. When the petitioner was transferred to the hospital a required post-accident drug screen was ran. A month later, the Robeson County Human Resources notified the Sheriff's Office that the petitioner tested positive for codeine and morphine. The Sheriff's Commission later informed the petitioner that probable case exists to believe that his justice officer certification must be summarily suspended. The letter that was sent to the petitioner stated that the Commission was informed that the petitioner produced a positive result on a drug screen and that pursuant to 12 NCAC 10B .0204(b)(5) they were required to revoke certification and that in accordance with 12 NCAC 10B .0410, the sanction, in this case the certification revocation, shall be for a period of not less than five (5) years.

Mr. Thomas stated that upon returning from a vacation, he had been feeling unwell and took some over-the-counter medicine from his mother's house, which caused a positive drug result.

Attorney Danny Earl Britt Jr. with the North Carolina General Assembly spoke to the Sheriffs' Commission Via Teams regarding Mr. Thomas case. He stated that everyone had been in a situation like his before and taken over-the-counter medicine to cure some kind of sickness.

Lt. Cobey Houser spoke to the Commission and stressed that they do not take any negative action regarding Mr. Thomas certification.

Chairman Jones asked the Commission if there were any more questions.

A **MOTION** was made by Sheriff Alan Norman to enter closed session; seconded by Sheriff James McVicker. **MOTION CARRIED** 

A **MOTION** was made by Commissioner George Dunlap to enter open session; seconded by Sheriff James McVicker. **MOTION CARRIED** 

A MOTION was made by Sheriff James McVicker in the matter of Todd Thomas; to adopt the proposal for decision as recommended by the ALJ that Petitioner's certification be **REVOKED** for **FIVE** (5) **YEARS**; however, the revocation be suspended, and Petitioner be placed on **PROBATION** for a period of **TWELVE** (12) **MONTHS**; seconded by Sheriff Chip Hughes. **MOTION CARRIED**.

#### \*Junior Thompson

Mr. Junior Thompson was not present for the proceedings. Mrs. Joy Strickland presented oral arguments regarding the case against Mr. Thompson. She presented that the petitioner has served as a Jailer with the Columbus County Sheriff's Office since March 23, 2020. Petitioner had listed a Bigamy charge on his application from 1998 but stated that the charge had been destroyed and removed from the clerk's database, however the Bladen County Clerk of Court was able to provide a copy of the disposition showing he was charged with the Felony Offense of Bigamy. Mrs. Strickland stated that the Commission shall revoke or deny the certification of a justice officer when the Commission finds that the applicant for certification or certified officer has committed or been convicted of a felony.

Chairman Jones asked the Commission if there were any questions.

A MOTION was made by Sheriff Lowell Griffin to enter closed session; seconded by Sheriff Chip Hughes. MOTION CARRIED

A **MOTION** was made by Sheriff Van Shaw to enter open session; seconded by Commissioner George Dunlap. **MOTION CARRIED** 

A **MOTION** was made by Commissioner Marc Nichols in the matter of Junior Thompson; that Petitioner's justice officer certification is **DENIED PERMANENTLY** pursuant to 12 NCAC 10B.0204(a)(1) and 12 NCAC 10B.0205(1)(a) due to him committing the Felony offense of Bigamy in violation of N.C.G.S 12-183; seconded by Sheriff Lowell Griffin. **MOTION CARRIED.**
