• 12 NCAC 10B .0601 – Minimum Standards of Training for Detention Officer

During the pilot run of DOCC, she stated that there were some minor changes that needed to be made moving forward regarding the curriculum. She stated that there would be no changes in the number of hours for the training and no changes in the topics being delivered.
