<u>Periodic Review and Expiration of Existing Rules Report</u> <u>12 NCAC 10- Sheriffs' Education and Training Standards</u> <u>Commission</u>

Purpose:

N.C.G.S. 150B-21.3A requires that all rules adopted under G.S. 150B, Article 2A, be reviewed every 10 years by the agency that promulgated the rules to ensure rules are necessary and within the agency's statutory authority. The N.C. Sheriffs' Education and Training Standards Commission's rules are located in Title 12, Chapter 10 of the N.C. Administrative Code. The first step in this process is for the Commission to classify each rule as "necessary" or "unnecessary." An unnecessary rule is defined as "a rule the agency determines to be obsolete, redundant, or otherwise not needed." [G.S. 150B-21.3A(a)(6)]. A necessary rule is defined as "any rule other than an unnecessary rule." [G.S. 150B-21.3(a)(2a)]. Any rule classified as "unnecessary" will be removed from the Code. All rules classified as "necessary" must be readopted as if they are new rules using the permanent rulemaking process, pursuant to G.S. 150B, Article 2A.

In compliance with this statute, the Sheriffs' Commission has conducted a review of the Commission's existing rules and made an initial determination as to the classification of each rule as set forth in the attached Periodic Review and Expiration of Existing Rules Report. The Commission will accept written public comments on these classifications for the period noted below.
