#### \*N.C. Sheriffs' Association

# Mr. Eddie Caldwell of the North Carolina Sheriffs' Association addressed the Sheriffs' Commission with his updates.

The 2025 Sheriffs' Executive Assistants' Institute was held during the week of January 5th–10th with graduation being held on Friday, January 10th. 61 students have graduated.

The 2025 Spring Meeting will be held in Wilmington, April 25th–29th. Registration information was sent in late February.

The 2025 Legislative Day meeting date has moved to June 3rd–4th. A Retired Sheriffs' Luncheon will be held on June 3rd. At this luncheon, the Sheriffs' Standards Division Director customarily provides an update on the Sheriffs' Supplemental Pension Fund.

The 2025 Jail Administrators' Institute of Leadership will be held October 12th–17th. Registration information will be sent in the next few weeks.

The 2025–2026 Legislative Session started January 29th.

The bill filing deadline for the Senate is March 25th and for the House is April 3rd.

House Bill 50, LEO Special Separation Allowance Options–received a favorable report on March 4<sup>th</sup> from the House Judiciary 1 Committee and was referred to the House State and Local Government Committee for further consideration. A status update will be provided at the Sheriffs' Education and Training Standards Commission meeting on March 21st.

The Association has participated in many productive meetings with Attorney General Jeff Jackson and members of his staff including Criminal Bureau Chief Boz Zellinger and Senior Deputy Attorney General Joy Strickland to discuss and keep the Attorney General's office aware of the current and future needs of North Carolina sheriffs.

Mr. Anderson reported on training statistics for In-Person Courses, In Person Students, Online Courses, Online Instructor Updates and SRO Updates.

# **\*BLET REVISIONS Updates**

Mr. Gazaway presented an update on the BLET update Revision; BLET Curriculum & Instructor Update was held December 12, 2024, at Western Piedmont Community College, led by Bryan Christie. # Specialized Instructor Updates (Firearms & CCT):

- Updates published in Acadis and distributed via email.
- Deadline: December 31, 2025.
- 685 Firearms and 91 CCT instructors still need to complete updates.
- Monthly sessions for Firearms are ongoing through 2025.
- CCT (formerly SCAT) is offered statewide, including east/west campuses.
- A new pilot instructor course for CCT began on March 10, 2025.

# Second Pilot Deliveries (July–Dec 2024):

- 8 schools participated: 6 completed by December 2024.
- 100% pass rate on the state exam.
- CMPD and Carteret CC (night class) to graduate in April 2025.

# **BLET 2025 Implementation:**

- 40 schools using 2025 curriculum.
- 18 schools finishing legacy curriculum by June 2025.

# **Progress Highlights:**

- Feedback-driven curriculum improvements.
- Key successes: webinar participation (803 completions), online testing implementation, and validated exam questions.

# Next Steps:

- Ongoing curriculum validation and field feedback collection.
- Continued support and guidance for schools, directors, and instructors.
- NCJA now has three full-time BLET field reps: West: Amber Burgess Cox, Central: Aaron Moore and East: Chris Cooper.

# \*NC Law Enforcement Accreditation

# **Amy Thompson**

Amy Thompson presented an update on NCLEA. To date, 80 agencies have submitted online enrollment applications for accreditation, including 15 Sheriff's Offices. The Application and Enrollment Coordinator has trained 63 new Accreditation Managers individually, with 5 more scheduled for training. Fourteen agencies are expected to complete the self-assessment phase and undergo reviews in 2025, while 42 agencies are projected to complete assessments in 2026. To support this demand, the NCLEA Assessment Coordinator created an online Assessor training course, with 15 Assessors completing refresher training and 10 new Assessors completing the initial course - 8 of whom have also received required one-on-one training. Efforts are underway to expand the Assessor pool in preparation for the upcoming assessments. The Lincolnton Police Department received its first NCLEA award in November 2024, and the Knightdale Police Department is set to receive its award in May 2025. Additionally, the federally funded Mentor program continues to support accreditation efforts, with 8 Mentors currently assisting 40 agencies.

#### \*Probable Cause Committee

Sheriff McMahon reported that the Probable Cause Committee met on March 20, 2025. During that session, the Committee reviewed a total of thirty-nine (39) cases. Ten (10) cases were closed pursuant to the Probable Cause Policy. No probable cause was found in six (6) cases. Probable cause was found in twenty (20) cases with thirteen (13) of those cases resulting in Consent Agreements. Eleven (11) Consent Agreements were signed and are presented for approval today. Two (2) of those Consent Agreements may be executed at your next meeting. One (1) case was postponed until the June 2025 meeting. One (1) case was continued for further investigation.

# VIII. DIVISION REPORT

Deputy Director Jones presented the Division Report to the Sheriff's Commission. She advised that the Division has hired the following personnel:

b. Leya Drumm–Administrative Assistant for the tele communicator officer program. Her first day was January 13,2025.

c. Keith Perkins–Criminal Justice Specialist/Inv III–Professional Certificate Program & In-Service Program Manager. His first day was March 3, 2025.

Vacant Positions

The Division currently has three vacancies. One of the positions, the Division's Rules Coordinator and Investigator, was previously held by Melissa Bowman and is in the HR process to be filled.

The second position is the Certification Manager and Training Evaluation manager. This position was previously held by Chris Scott. We are working to update the job responsibilities for this position.

The Division is also in the process of selecting a new Director.

# **\*POSITION REQUESTS**

The Division currently does not have any staff members whose sole function is investigations. The Division currently utilizes the three (3) field representatives to assist with investigations. These field representatives also conduct audits and deliver testing. The Division has requested two (2) full-time investigators (Criminal Justice Specialist/Investigator III) positions.

The Division utilized a part-time administrative assistant position to support the Professional Certificate Program and In-service Program. The Division has requested one (1) full-time administrative position to support these programs.

The Division also requested one (1) full-time attorney position to support the Division and the Commission. DOJ currently has an attorney assigned to support the Division, but this attorney has other clients assigned to it as well.

# **\*RETIRED SHERIFF SUPPLEMENT FUND**

# \*CRIMINAL JUSTICE COMMISSION INFORMATION – INSTRUCTOR SCHOOL PROPOSED REVISION

At their February 2025 meeting, the Criminal Justice Education and Training Standards Commission voted to move forward with a proposal to split the Instructor Training Program into two parts, Instructor and Developer. The instructor portion would focus on delivery skills, aspects of teaching adults, and adult learning. The Developer portion would focus on research, writing lesson plans, and writing appropriate testing instruments. The proposal would create two certifications, one for Instructors and one for Developers. The Committee directed the NC Justice Academy to develop the requisite program.

This new rule sets forth the requirements of N.C.G.S. 17E-16 for agencies to report critical incidents to the Division to be maintained in a database.

The above rules streamline the process of the later transfer of in-state law enforcement officers. The Commission previously voted for rulemaking authority for these rules. A public hearing has been held and the public comment period ended on March 17, 2025. If adopted by the Commission, these rules will be submitted to the RRC within 30 days and if approved, the effective date will be June 1, 2025.

Robin Pendergraft has been assigned as the rules review coordinator for the Commission. Robin and legal counsel have been working together on all rules related projects. The new rules review coordinator will be assigned in consultation with the Commission Chair.
