- Davidson-Davie Community College for a period of five years for BLET, Instructor Training, and SMI
- Randolph Community College for a period of five years for BLET, Instructor Training, and SMI.
- Lincolnton Police Department received NCLEA accreditation. A certificate of appreciation was presented to Ms. Jennifer Harris for her contributions to the NCLEA Program.
- CJ Division staff evaluated the applications of two hundred and eighteen (218) candidates. There were one hundred and fifty-six (156) candidates for the Advanced Law Enforcement Certificate and sixty-two (62) candidates for the Advanced Criminal Justice Certificate. Each of these applicants met the requirements to receive the Advanced Certificate and the Advanced Certificate pin.

Important Changes in CJ Standards Application Processes

The Criminal Justice Standards Division has made significant strides in modernizing its processes during 2024. Here's an overview of the improvements and upcoming changes.

Online Transitions:

The Division has successfully moved several key processes to the Acadis portal:

- Concealed Carry Handgun Instructor applications
- Ordering of Concealed Carry Handgun certificates
- Retired Law Enforcement Officer Firearms applications
- Company/Campus Police agency and officer applications

These transitions have been met with enthusiastic approval from applicants, who appreciate the streamlined and efficient online process.

Important Deadline:

Effective April 1, 2025

- Paper checks and applications will no longer be processed.
- All submissions will be returned if not submitted through the Acadis portal.

New Requirements:

Moving forward, all applications and certificate orders must be completed exclusively through the established online processes in the Acadis portal.

This shift to digital processing aims to enhance efficiency, reduce processing times, and improve overall user experience for all stakeholders involved in these certification and application processes.

New Webinar Series

To help ensure that instructors are prepared to deliver the new BLET content, the Justice Academy staff has created an 18-part webinar series that includes a panel discussion involving pilot School Directors and their instructors relaying the most critical points concerning the new curriculum. Each webinar is one hour long, and the attending instructors can print their transcripts to show to their Academy Directors when they have completed their training. So far, over 650 instructors have logged on to the NCJA Acadis online training portal to take these courses. They are available for all certified instructors and can be found here. Search for BLET to find the courses. We encourage you to enroll and complete the webinar segments covering specific topics you intend to deliver or when the course content overlaps with a class you will be teaching. A big thanks goes to former NCJA Director Peggy Schaefer for her work in creating this webinar series.

Over the past year, the CJETS Commission has worked diligently to revise numerous rules to support the implementation of the new Basic Law Enforcement Training (BLET) program. We also regularly add or update rules in response to changes within our profession.

The rules review process involves submitting drafted rules to the Rules Review Commission (RRC), a separate state entity, for final approval. This is a lengthy process which often requires rewrites and adjustments before the final rules are approved. And, in some cases, rules are delayed that may

impact

personnel in the field.

Below is an update on the status of a few key rule changes, and their impact.

Key Changes to Rules from 2024:

1. Deletion of 12 NCAC 09E .0105

This rule was deleted, primarily because it was the rule that had to be updated every year and formerly listed the 2022 in-service classes. The requirement for 24 hours/credits of in-service training will be moved into 12 NCAC 09E .0108 effective May 1, 2025.

2. Updates to 12 NCAC 09E .0106

Proposed revisions to this rule were paused in December due to anticipated objections from RRC and conflicting feedback from law enforcement professionals. The current rule maintains the minimum qualification score of 70% for in-service firearms qualification while requiring that the qualification course "not be less stringent" than the BLET course requirements for firearms qualification. Additionally, the rule provides that the **In-Service Firearms**

Qualification Manual "shall be applied as a guide for conducting the annual in-service firearms qualification."

What this means in 2025 for Mandatory In-Service Firearms Training:

- 1. Rule 12 NCAC 09E .0106, copy attached, remains in effect.
- 2. The **In-Service Firearms Qualification Manual July 2018 Edition** "shall be applied as a guide for conducting the annual in-service firearms qualification."
 - a. Previously used 30 round courses may still be used in 2025.
 - b. Previously used combat courses may still be used in 2025.
 - c. Any content from the BLET 2025 may also be used in 2025.

After qualification, nothing prohibits an agency from creating or using other training concepts or tactics to include additional courses of fire or more challenging combat courses that meet agency needs.

Updates that have been proposed and any others that are proposed will be evaluated as the Commission moves forward, gathers input, and builds consensus on future in-service firearms training standards. We anticipate that any changes adopted by the Commission will be implemented with a proposed effective date of January 1, 2026. In this process, we will evaluate best practices, seek input from firearms subject matter experts, and have draft rules ready for review and approval at a future Commission meeting in 2025.

DAC Certification Team 2024 Highlights J. Eric Preddy, Criminal Justice Specialist/Investigator III, Criminal Justice Standards Division

We're excited to share the latest updates and highlights from our team's activities. Here is a breakdown of our key actions and milestones from 2024:

Correction Officer Probationary Certifications Issued: 1356

Correction Officer General Certifications Issued: 778

Probation/Parole Officer Probationary Certifications Issued: 256

Probation/Parole Officer General Certifications Issued: 104

2024 Applications Processed: 1455 (average 122/month)

Referred to Investigations: 87

As many of you are aware, we experienced a significant backlog in reviewing applications for certification throughout much of the year due to several factors beyond our control. In July, we were approximately 1100 applications behind. Director Smythe approved several aggressive efforts to alleviate the backlog and bring us to our goal of a two week turnaround in application processing. Efforts included creating a dedicated and equipped space specifically for DAC certification processing and adding temporary certification staff. Eight people were dedicated to the backlog effort and the "DAC Certification POD" began operations in July. The team has worked diligently since beginning operations and achieved their main goal of alleviating the backlog before the December holidays.

These figures and outcomes reflect the ongoing commitment and hard work of our team. From handling critical file uploads to conducting thorough reviews, every task plays an essential role in our continued success.

News from Juvenile Justice

We are excited to share the latest updates from our team's activities in 2024. Both challenges and successes marked this past year as we continue to support professionals in the criminal justice field. Here is a summary of our key actions and milestones:

Juvenile Justice Officer Certifications Issued: 263 Juvenile Court Counselor Certifications Issued: 122

At the beginning of 2024, we faced a hurdle: a significant 8-week delay in processing applications. We recognized that this delay impacted our team and the individuals relying on our services. In response, the Division took decisive steps to address the backlog and improve the overall efficiency of our processes. A significant step involved hiring additional employees and providing extended resources to support the processing of certifications. This expansion allows us to handle the volume of applications and expedite the approval process, reducing delays and improving service delivery.


