# THE PROFESSIONAL CERTIFICATES ARE AWARDED AT THREE LEVELS AS FOLLOWS:

#### BASIC LAW ENFORCEMENT CERTIFICATE

An officer can qualify for thee **BASIC CERTIFICATE** if he or she has:

- \* Completed the probationary period required (at least one year), and has demonstrated proficiency in the performance of official duties, and
- \* has successfully completed an accredited Basic
  Training Course for law enforcement officers or
  have completed a minimum of 160 hours of
  training in the field of law enforcement and
- \* holds a General or Grandfather Certification.

## INTERMEDIATE LAW ENFORCEMENT CERTIFICATE

An officer can qualify for the **INTERMEDIATE CERTIFICATE** if he or she:

- \* meets the requirements for the BASIC CERTIFICATE
  . and
- \* has accumulated at least thirty-nine (39) points (consisting of at least 20 law enforcement training points) and at least eight (8) years experience, or
- \* has accumulated at least sixty-nine (69) points (consisting of at least 35 law enforcement training points) and at least six (6) years experience, or
- \* has accumulated at least ninety-nine (99) points (consisting of at least 50 law enforcement training points) and at least four (4) years experience, or
- \* has an Associate Degree from an accredited technical institute, technical college, community college or university; has accumulated at least twenty-four (24) law enforcement training points and at least four (4) years experience, or
- \* has a Baccalaureate Degree from an accredited college or university; has accumulated at least twenty-three (23) law enforcement training points and at least (2) years experience.

#### ADVANCED LAW ENFORCEMENT CERTIFICATE

An officer can qualify for the **ADVANCED CERTIFICATE** if he or she:

- \* meets the requirements for the INTERMEDIATE CERTIFICATE, and
- \* has accumulated at least sixty-nine (69) points (consisting of at least 35 law enforcement training points) and at least twelve (12) years experience, or
- \* has accumulated at least ninety-nine (99) points (consisting of at least 50 law enforcement training points) and at least nine (9) years experience, or
- \* has an Associate Degree from an accredited technical institute, technical college, community college or university; has accumulated at least thirty-three (33) law enforcement training points and at least nine (9) years experience, or
- \* has a Baccalaureate Degree from an accredited college or university; has accumulated at least twenty-seven (27) law enforcement training points and at least six (6) years experience, or
- has Graduate or Professional Degree from an accredited college or university; has accumulated at least twentythree (23) law enforcement training points and at least four (4) years experience.

#### POINT COMPUTATION FORMULA

Professional certificate awards are based upon a formula which combines formal education, law enforcement training, and actual experience as a law enforcement officer. Points are computed in the following manner.

- \* Education Each semester hour of college credit shall equal one point; each quarter hour shall equal two-thirds points.
- \* Degrees- Applicants holding degrees will not be awarded additional points for those degrees and must instead meet the training point requirements of this Section through completion of law enforcement training
- \* Training Twenty classroom hours of Commission approved training gained in an officer's area of expertise shall equal one point. (Note: D.O.C. and Detention Training not pertaining to an officer's area of expertise shall not be credited.)
- \* Experience Only Full Time experience as a sworn member of a law enforcement agency or the equivalent experience shall be accepted for consideration.

### THE SERVICE AWARDS ARE AWARDED

#### AS FOLLOWS:

#### INTERMEDIATE SERVICE AWARD

An applicant can qualify for the INTERMEDIATE SERVICE AWARD if he/she:

- \* is an elected or appointed Sheriff, or
- \* holds General or Grandfather Certification, and
- \* has a minimum of fifteen (15) years of service as a Full Time certified justice officer.

### ADVANCED SERVICE AWARD

An applicant can qualify for the **ADVANCED SERVICE AWARD** if he/she:

- \* is an elected or appointed Sheriff, or
- \* holds General or Grandfather Certification, and
- \* has a minimum of twenty (20) years service as a Full Time certified justice officer.

# HOW TO APPLY FOR A PROFESSIONAL CERTIFICATE

- A. Compute your qualifications. How many college credits do you have? How many hours of law enforcement training do you have? Convert these hours to points as described in the chart on the back on this brochure. How many years of Full Time experience do you have?
- **B.** Compare your degree or accumulated points and your total experience as a sworn member of a law enforcement agency with the certificate requirements in this brochure. Do you qualify?
- **C.** If you are qualified to receive an award, request an Application Form F-6 from your agency head or the agency personnel officer.
- D. Complete the application fully and attach the necessary documents to verify your qualifications. Education and training MUST BE supported by transcripts, copies of diplomas, official training records, or other reliable documentary materials.
- E. Return the application to your agency head for his/her endorsement. No award will be issued unless recommended by an agency head.

- **F.** Your agency will forward the application to the Sheriffs' Education and Training Standards Division.
- G. After consideration of your qualifications, if the omission elects to grant the award, your proper certificate will be presented through your agency. Applicants should note that Advanced Certificate and Advanced Service Award applications must by presented to the Commission for approval at quarterly meetings. This requirement may result in a 3-4 month processing period for the Advanced award.

#### HOW TO APPLY FOR SERVICE AWARDS

- A. Compute your total years of service as a certified justice officer.
- **B.** Complete the Application Form F-6.
- C. Have application signed by your agency head no award will be issued unless recommended by an agency head.
- **D.** Forward application to NC Sheriffs' Education and Training Standards Division.
- **E.** If the Commission elects to grant the award, the proper certificate will be presented through your agency.
