MOTION BY STATE OF NEW YORK ON BEHALF OF THE STATES OF NORTH CAROLINA AND PENNSYLVANIA TO ADOPT THE PREVIOUSLY FILED AMICUS BRIEF

The State of New York, amicus curiae in this appeal, moves on behalf of the States of North Carolina and Pennsylvania for permission for these States to adopt the amicus brief filed on April 5, 2017, in support of Plaintiffs-Appellees by the States of New York, California, Connecticut, Delaware, Hawai'i, Illinois, Iowa, Maine, Maryland, Massachusetts, New Mexico, Oregon, Vermont, Virginia, and Washington, and the District of Columbia.

The deadline for filing an amicus brief in support of Plaintiffs-

Appellees was April 5, 2017. On the evening of March 31, 2017, New York circulated a draft of its amicus brief to all other States through the National Association of Attorneys General, and through additional emails.

States generally require substantial time to consider amicus participation, and joining an amicus brief typically requires multiple levels of consultation and review. Not all States were able to complete the review process by the April 5, 2017 deadline.

Since New York filed a multi-state amicus brief on April 5, 2015, two other States have concluded their review and now wish to join that brief. New York accordingly requests that the Court grant permission for these States—North Carolina and Pennsylvania—to adopt the subject multi-state amicus brief previously filed, or any other relief the Court deems appropriate.
