\* Officers may submit information attesting that particular types of training are applicable to their current duties and responsibilities. For example, detention officers would not normally receive credit for law enforcement drivers' training; however, a detention officer who regularly drives the prisoner transport van would certainly need this type of training to perform his or her duties, and could therefore receive credit for the training.

\* In addition, there are particular types of training which are county specific (such as boating safety courses and scuba diving), and will be evaluated on an individual basis.

- Computerized Video Training, *unless it meets the requirements for alternative training methodologies.*
